- Leads the senior management team providing oversight and ultimate responsibility for the human, financial and physical resources and the programmatic operations of the Commission.
- Exercises general management supervision of the work of the Commission, giving direction and guidance to ensure that the Commission provides sound professional advice and support to the public.
- Acts as the principal public relations agent for the Commission, fostering sound relationships with key stakeholders including the Government, private sector and the wider public.

The Candidate

- Postgraduate degree in Business Administration, Management, Law, Economics or other related discipline.
- At least ten (10) years' experience in a strategic leadership role, with at least five (5) years working knowledge of regulatory issues.
